Terms of Application

APPLICATION FEE AND TUITION

Tuition for the 2010-2011 program year will be \$2500.00 and may be paid by the individual or sponsoring organization. A \$50 nonrefundable application fee (personal funds) must be submitted with the completed application. If selected, you will be billed for the full tuition amount of \$2500.00. Your application fee of \$50 represents your personal commitment to the program and is required of each applicant and must be submitted with this application. The application fee is in addition to the tuition amount.

I understand the purpose of the Leadership Washington County program and that completion of this application does not guarantee my selection. If selected, I will commit the time required. I understand and acknowledge that my application fee is non-refundable and once I am accepted, that my tuition is non-refundable if I am dismissed due to attendance or failure to attend the Orientation Retreat, or if I voluntarily withdraw for any reason.
